**DEMURRAGE RATES CHART**

THIS CHART IS PROVIDED AS AN AID FOR COMPUTING CUMULATIVE **DEMURRAGE** CHARGES. REFER TO THE CURRENT PORT OF LOS ANGELES TARIFF FOR VERIFICATION OF RATES. General Cargo rates are \$0.81 per day for the first five days, \$1.64 per day for days 6-10, and \$3.28 per day for days 11+. The rates for containers measuring 0-7 meters are \$24.83 per day for the first five days, \$49.60 per day for days 6-10, and \$99.20 per day for days 11+; containers measuring 9-13 meters are \$49.66 per day for the first five days, \$99.32 per day for days 6-10, and \$198.64 per day for days 11+; containers measuring 13 or more meters are \$64.84 per day for the first five days, \$129.66 per day for days 6-10, and \$259.32 per day for days 11+. Rates for DEALER AUTOS and for autos OUTBOUND IN DOMESTIC TRADE are \$2.42 per day per vehicle for the first five days, \$4.82 per day per vehicle for days 6-10, and \$9.64 per day per vehicle for days 11+. ALL autos shipped INBOUND are \$8.07 per day per vehicle for the first five days, \$16.14 per day per vehicle for days 6-10, and \$32.28 per day per vehicle for days 11+. Except for automobiles and pickup trucks, DEMURRAGE IS SUBJECT TO A MINIMUM CHARGE OF \$24.14. Refer to current Port of Los Angeles Tariff for other applicable rates. **These rates are effective October 1, 2023.**
